RENTAL POLICIES:

- EXISTING CONDITIONS: User acknowledges and understands that the Premises comprises one or more outdoor facilities. City cannot predict the weather or other environmental conditions such as insects, wildlife, uneven terrain, wet grass and puddles, dirt, dust, noise from other park users, or other unpredictable, unknown, or natural factors that occur in a public park or outdoor facility. City will use its best effort to provide the Premises at an acceptable level of service consistent with that provided to all public users.
- PARKING: Parking is limited. User is encouraged to explore alternate locations for parking or methods of getting participants to the Premises. The City reserves the right to limit the number of participants in any given function or deny the use of a particular park area.
- RECYCLING: Recycling is encouraged. All recyclables shall be disposed of at a designated facility.
- AMPLIFIED SOUND: User shall respond promptly and appropriately to any complaints regarding excessive noise, up to and including removing the noise source (RMC 9.16).
- TRAIL COURTESY: Stay right except to pass, walk/run only two abreast, stay on designated pedestrian trails when available, be aware, and show respect to non-event users of trail facilities.
- INFLATABLE STRUCTURES/TOYS: Inflatable provider must provide a certificate of liability insurance naming the City of Richland as additional insured. Inflatable toy/ride providers must also be on the list of WA State L&I Amusement Ride Operators.
- PICNIC TABLES: Picnic tables are not guaranteed.

PARK RULES:

- PARK HOURS: 5:00am-11:00pm
- DOGS: Dog owners must comply with leash laws (on a leash less than 8 feet long or at heel—positioned and controlled to remain within 2 feet of the owner)
- ALCOHOL: No alcohol without required permits
- SMOKING: No smoking within fifty (50) feet of playgrounds. No cannabis consumption allowed on public property
- LITTERING: No littering, dumping of trash, or garbage
- WEAPONS: No discharge of weapons unless allowed by local, state, or federal law or through a special permit or authorization
- VEHICLES: No unauthorized vehicles on the turf
- CAMPING: No camping - except by permit
- FIRE: No campfires. Portable propane and portable charcoal grills are allowed
- FIREWORKS: No fireworks—except professional, by permit

REFUNDS/CANCELLATIONS:

- All event cancellations must be made in writing.
- Cancellations made 14+ days before the event date receive a full refund of the agreed hourly rental fee.
- Cancellations made 7-13 days before the event date receive 50% of the agreed hourly rental fee.
- Cancellations made 0-6 days before the event date receive no refund of the agreed hourly rental fees.
- Damage deposit refunded in full if canceled before the event.
- Administration fee is non-refundable (only pertains to Special Event Agreements).
